- 2. Resolved to display posters with the helpline numbers at prominent places in the campus.
- Resolved to make all those concerned aware of the Code of Conduct of the college, norms
 for use of library, laboratory, office and public places and also the consequences of
 violating the code.
- 4. Resolved to get declaration form signed by all those concerned accepting the code.
- Resolved to make the women students know about the procedure for filling complaints in case they get affected.

- 6. Resolved to conduct the detailed enquiry within 15 days from the day of incidentce and the guilt should be proved, beyond any reasonable doubt with adequate evidences. Once the guilt is proved the concerned persons should be punished as per the guidlines issued by the Government of Tamil Nadu.
- As there was no other matters to be discussed, the meeting was conculded with the vote of thanks proposed by the convenor.
