ORDER:

The Commissioner of Collegiate Education has forwarded the application submitted by the Kovai Kalaimagal Educational Trust, Coimbatore to open an Unaided Private Co-Education College in the name of Kovai Kalaimagal College of Arts and Science in Coimbatore. The Commissioner of Collegiate Education has stated that the management has provided the following:

i. An Endowment of Rs.10/- lakh (Rupees ten lakhs only) has been created in the joint name of Director of Collegiate Education and in the name of the Trust. The said amount was remitted in the Indian Bank, Chenniampalayan, Coimbatore for 5 years on 28.10.93.

ii. The Management has purchased 10.15 Acres of lands at Vellimalai Pattinam Village in Survey No.129/2 and 118.

iii. Agreement in stamp paper to abide by all conditions prescribed by the Government.

2. The Government have examined the proposal ~~xxx~~ carefully and they permit the Kovai Kalaimagal Educational Trust to open a Self-financing Co-Educational College in the name and style of Kovai Kalaimagal College of Arts and Science, Coimbatore during 1996-97 with the following courses:



1. B.B.M.,
2. B.Com.,
3. B.Sc., Bio-Chemistry

3. The Management is permitted to start the college during 1996-97 temporarily (the building with R.C.C. Structure situated at 1.13 acres of lands which are taken on rental basis at P.N. Palayam Road, Ganapathy, Coimbatore and it should be shifted to the permanent building during 1997-98 to be constructed in the land mentioned in para 1 (ii) above.

4. The permission granted in para 2 above is also subject to the following conditions:

1. Affiliation from the Bharathiar University, Coimbatore should be obtained for the college from the year 1996-97 and before the commencement of all courses of study.

2. The land mentioned in para 1 (ii) above should not be utilised for any purpose other than college purpose.

3. The Government will not grant any financial assistance at any time.

4. The management should satisfy all the conditions prescribed in G.O. Ms. No. 958, Education, dated 15.7.89.

5. No other courses of study except science Arts and Commerce courses, allowed by the Government/University should be conducted.

6. The teaching and non teaching staff shall be appointed as per the yardstick and they should possess the prescribed qualifications.

7. If the management creates a situation causing the closure of the college for any reasons, the Government will not come forward to take over.
