The meeting commenced with a welcome address by the Principal.

The principal explained the seriousness of the ragging problem and the various letters received from UGC, Government of Tamil Nadu, and Bharathiar University, Coimbatore about curbing this menace by taking suitable actions.

After discussion the following have been decided.

- Anti Ragging committee instructed to IQAC to conduct a seminar on the topic “ Anti Ragging and its Impact” for all the senior students
- To explain what are all the different kinds of activities which can be categorised under ragging and to advice the students not to be present in the site where it is suspected that ragging is going on.
- To be more vigilant at the probable sites of ragging namely canteen, hostel, bus stop, rest room, parking lot and in the veranda by posting patrol parties consisting of senior faculty members at such places.
- To put up fresh flex banners at different notable places which are frequented by the students explaining the punishment to be given to the students who are involved in ragging activities.
- To install complaint boxes near the college office, library, hostel warden’s room and the students may be asked to inform the Principal in writing about any incident of ragging if they come across and put it in the complaint box without being noticed by anybody else. The complaint box is to be opened once in three days to find out whether there is any instant of ragging for taking suitable action subsequently.
- The students who are affected by ragging incidence or who want to give information about the involvement of a group of students in ragging junior students may also prefer to lodge a complaint either through phone or e-mail in order to keep anonymity
- To give online undertaking to effect that we will not indulge or yet involved in ragging activities in the concerned web portal <https://antiragging.in> by all the students
- To conduct an enquiry in case of any complaint and if it is established that the concerned students are guilty then such students are to be handed over to the police for suitable action

As there was no other matter to be discussed, the meeting came to an end with a vote of thanks proposed by Dr. V.Vijayalakshmi
